





PEOPLE + PLACE

The survey respondants reinforced similar themes to those expressed by the Community Vision Working Group. The most common issues raised included a lack of basic services and a shortage of housing.

Strong sentiments were also expressed around the importance of growing and supporting the Town and a strong community, and not just investing all efforts towards the growth of tourism.

The community is wary of growth – and does not want its small town charm to be overrun by Tourism, or new development that is not in keeping with existing character.




- "Lots of money being spent on tourism which is great for the town but the actual locals are needing more for or children and older folks.

- "It grows too big and loses its character. It becomes more of a transient population of renters decreasing the overall appeal of the town.





PROSPEROUS ECONOMY

There are diverging views amongst the Community with respect to key industries that should support the Town into the future. Local jobs and employment diversity has been identified as a key issue.

A proportion of the community see Mining as an important industry that can provide diversity, but many respondents are concerned about the impacts of Mining on the Environment, Tourism and Town itself.

When asked about potential risks to economic expansion, waste and noise management, road safety and insufficient infrastructure were perceived to be of most concern.

Indecision and uncertainty around Mining was also noted as the greatest barrier to investment, from the perspective of respondents.







ENVIRONMENT, CULTURE AND HERITAGE

Without a doubt, Environment, Culture and Heritage are critically important to Dwellingup's future.

Survey respondants demonstrated a passionate response for protecting the forest, sustainable practices and nature based, tourism activities. The need to be more proactive around sharing stories and promoting heritage and culture, including indigenous heritage also featured prominantly. The Hotham Valley Train and its Artists and Creatives were also identified as Dwellingup's Best Attributes and Assets.


A strong contingent of respondants do not support a mining footprint close to the Dwellingup Townsite.






ROLE OF ENVIRONMENT IN THE FUTURE

CONNECTIVITY, ACCESS, INFRASTRUCTURE AND RESOURCES


Improved access to health, education and an extended range of basic services was reinforced by respondants, when probed about Infrastructure and Services.

The range of suggested improvements put forward would equally benefit locals and well as visitors.


There are some conflicting outcomes noted between the suggested ideas which were ranked, and an open list of missing services. For example, health related services and community facilities were ranked amongst the lowest ideas, yet also mentioned most frequently by respondants when asked to list up to 5 missing services that should be prioritised.

A better range of shops, retail, cafes and restaurants, childcare and public transport once again featured as strong themes.



GOVERNANCE, TRANSPARENCY + COMMUNICATION

Survey respondents have put forward a number of suggestions to improve the way the Dwellingup community can work better together.

By the responses received, there appears to be concern around the distribution of information, and the current engagement tools applied. The response suggests the need to explore ways in which the community could work better together, into the future.



- "There are efforts, but the message just doesn't seem to be getting across.
 Liaison between various community groups, and the Shire might be a way to go."
- "Need to engage with the highly recognised expertise who live in the community and not with the over opinionated self serving individuals"
- "I am a Noongar Man who lives in Dwellingup, and I don't like how I am not a voice for Dwellingup."
- "I believe that
 the shire do an
 excellent job at
 communicating
 with the people of
 Dwellingup"

- "Government could state clear boundaries for mining buffers surrounding Dwellingup ensuring mining activities cannot be conducted close to town or the surrounding areas.
- Clear communication and governance regarding this would avoid unrest and negativity within the community towards the future plans and mining presence."
- "The Local Authorities need to address the actual residents and current business owners of the town. Organisations like the Dwellingup Community Compact don't seem to be attended by most residents or business owners."
- "An official channel of communication is needed. Currently there is a printed newsletter produced by the primary school (so not inclusive/general enough), and a Facebook page (not an official channel, plus older residents are not on Facebook). **A Dwellingup** newsletter or newspaper would be brilliant."
- "Dwellingup wants its own identity so the people of Dwellingup need to be encouraged and supported to assist with town development"
- "More scope for the 'silent' voices to have their say. Too often the vocal minority hold public sway."


