- Annual inspection Certificate for each amusement, if relevant\* •
- WorkSafe Plan Registration Certificate or Class 1 Certificate for each amusement, if relevant\* • \*The company supplying your equipment, will know which paperwork needs to be provided.

No amusement activities or bouncy castles are to be erected at any Shire facility, Reserve or Public Open Space without obtaining prior consent from the Shire of Murray.

The onus of responsibility to ensure bouncy castle / amusement activities are adequately secured / anchored and meets the Australian Standards and Work Safe Regulations lies solely within the hire company.
